ICD10 Adjustments

The approaching deadline of October 1, 2014 to enable the use of ICD 10 Codes in claims moved us to make specific changes in the DAQbilling product.

- The ICD Type has been added to the Encounter menu to determine if either ICD 9 or ICD 10 Diagnosis Codes will be used in the Encounter.

- GEM (General Equivalency Mapping) allows the User to go to the ICD GEM Search menu. The User uses the ICD Type to determine which ICD Codes will be searched in the ICD GEM Search menu. If the ICD Type is ICD 10, then the ICD GEM Search menu will search by ICD 9 for equivalent ICD 10 Codes. If the ICD Type is ICD 9, then the ICD GEM Search menu will search by ICD 10 for equivalent ICD 9 Codes.

ICD GEM Search window:

- Diagnosis Code menu: The ICD Type was added to allow the User to see which ICD Code version is currently being seen, either ICD 9 or ICD 10. The ICD Type changes automatically depending on which code is visible.

- Procedure Group: The ICD Type and GEM were added to this menu to allow the User to properly set up Procedure Groups using either ICD 9 or ICD 10 Codes.
