Introduction

This document contains information regarding the current DAQbilling release.

New Features and Enhancements

To meet Claim requirements that need more than six (6) Procedure Line Items per Claim, we have implemented an enhancement that will change how Encounters are saved and sent out electronically. A **Do Not Split Encounter** option was added to the Encounter. This feature allows for the Encounter to maintain all line items, when more than six, within the body of one encounter, instead of the traditional split into multiple Encounters. If an electronic claim needs to be rebilled on paper with an attachment, reopen the Encounter, create and attach the scanned file, clear the **Do Not Split Encounter** check box option, and save the Encounter. This allows the Encounter to now split into multiple claims that can be printed properly to paper. Please utilize this feature when needed to assist in your billing needs.
